ADDITIONAL TO YOUR RESERVATION

Dear guests,

With effect from May the 17 of 2021, travelling into our beautiful holiday country is possible again and we are very happy about that.

Restaurant visits, partly also in closed rooms, as well as individual leisure activities (fitness and sauna) are possible under certain conditions.

By order of the State Chancellery, this option can be terminated at any time, for example if the incidence value is over 100 on three consecutive days. Please be prepared for an immediate departure. In this case you will not incur any cancellation fees.

The following requirements apply to your trip (for business and tourism reasons)

- Before arrival, a negative corona test of all travelers, must be sent in digital form to fo-ahk@atlantic-hotels.de. The test results of all travelers must be presented to the hotel reception upon check-in. PCR laboratory tests (not older than 48 hours) and rapid antigen tests (not older than 24 hours, carried out by a test station) are accepted. Please pay attention that we do need a new test result after every 72 hours. The list of the test centers can be found bundled at <http://www.kiel-sailing-city.de/>.
- Children under the age of 6 and people with full vaccination against SARS-CoV-2 as well as those who have recovered (illness at least 28 days, but no more than 6 months ago) are exempt from the obligation to test. Please send us proof of vaccination (vaccination certificate, replacement certificate from the vaccination center or medical certificate) digitally before your arrival to fo-ahk@atlantic-hotels.de and present the original proof of this at the hotel reception upon check-in.
- All test results and your personal data are stored for 4 weeks and, if necessary, transmitted to the health department.
- If you do not provide this obligation to provide evidence (or not in time), we can make use of the option to terminate the accommodation contract immediately. All booked nights, including the remaining nights, will be billed to you in full, unused services cannot be reimbursed.
- In the case of a positive rapid test result, the hotel reception must be informed immediately, and a PCR test carried out. For the duration of the quarantine until the laboratory results are received, we provide a quarantine room is available to you.

- You will be billed for the additional costs for accommodation. If the PCR test is also positive, you must leave immediately. If desired and necessary, we will be happy to organize a return transport for you, the costs for this are at your expense.
- We use the Luca app to keep track of contacts in our gastronomy. With your signature, you confirm the documentation of your data with the Luca app and forwarding it to the health department upon request. For quick and easy handling, download the Luca app before your arrival.
- Our hotel bar on Deck 8 with the terrace are open for you between Monday and Saturday, but still with lower maximal capacities (50%). The bar acts as a restaurant in the evening and is open until 1.00 a.m.
- The breakfast times require coordination in terms of capacity and distance, which we act with you on arrival. We ask for your understanding that maybe not all desired times are possible.
- Inside the bar it is only allowed to sit together with max. 10 people from 10 different households.
- The general distance and hygiene rules are continued to exist, also for people who are full vaccinated.
